



THE GOILAMMIDDA EDUCATIONAL SOCIETY

1. Name of the Society: The name of the society shall be "The Goilammidda Educational Society, Goilammidda"
2. Registered Office: The registered office of the society shall be at Goilammidda

3. Objects of the Society:-

- The objects for which the society is established are:
- (a) to diffuse useful knowledge among the members of the society.
- (b) to establish educational institutions to develop knowledge of the surrounding villagers.
- (c) To co-operate with other institutions having similar objects as this Society.
4. The income and funds and properties of the association shall be applied solely toward the promotion of the objects of the society, subject to the conditions and trusts, if any annexed to the said Properties.

5. No person or persons in whom for the time being funds or money or any other property of the society may be vested shall be answerable for any loss arising in the administration or application of the said funds or money or property or for any damage to or deterioration of the said property, unless such loss or deterioration shall happen by or through his or their wilful default neglect or dishonesty.

THE GOLLALAMMIDU EDUCATIONAL SOCIETYGOLLALAMMIDU : : A.G.DISTRICT, (A.P.)

1. Name : This Society shall be called "The Gollalammidu Educational Society".

2. Office: The Society's Registered Office shall be located at Gollalammidu, A.G.Dist., Pin:533 544, Andhra Pradesh.

3. Constitution of the Society:-

The Society shall consist of the following classes of members:

a. Founder and Chief donor of the College.

b. Promoters: Those who contribute Rs.10,000/- and above shall be promoters of the Society. Their names will be inscribed on the wall of the College Building.

c. Patrons: Those that contribute Rs.5,000/- and above but less than Re.10,000/- shall be patrons of the Society. Their names will be inscribed on the wall of the College Building.

d. Life members: Those that contribute Rs.2,500/- and above but less than Rs.5,000/- shall be life members of the Society.

e. H.S.: Those who contribute Rs.5,000/- and above shall have hereditary right under the law of inheritance.

4. a. The General Body shall consist of a President, Two Vice-Presidents, Secretary, Treasurer and those that contribute to the society either in money or property.

b. The President, Vice-Presidents, Secretary, Treasurer shall be elected from among the General Body members by the General Body for a term of 5 (Five) Years at a special Meeting.

5. A member shall be raised to any higher category, if he pays the difference amount.

a. In case a group of persons constituting a firm, Society, Trust, Municipality and Local bodies benefit this society by donating a sum of Rs.10,000/-, Rs.5,000/-, Rs.2,500/- that group shall be entitled to nominate a representative of such a body and the nominated representatives only shall be entitled to membership of the society.

b. In case of the hereditary members, only one of the descendants of the member shall be a member of the society at any time. The descendants or heirs at law of the hereditary member shall nominate any one member from within the family or from outside. In case of the member nominated is from outside the family, the family shall have the right to fix the duration of his membership, either for his life, or for a term of every Five Years.

c. If there shall be any difference of opinion about the heir or nominees of a retiring or deceased member the decision of the Governing body shall be final.

6. In view of money, Property, given by way of gift or gift-deed shall be accepted and the valuation shall be made by the Governing body.

7. a. Any member may resign his membership in writing, on his membership shall cease from the date of its acceptance by the executive body of the General body.

b. The membership of any person shall cease from the date of his death or is adjudged as insolvent or is convicted by a Court of Law in a Criminal Offence.

8. Functions of the General Body:-

(a) The General Body shall at least meet once in a year ordinarily in the month of June to transact the following business:

i) to take stock of the activities of the previous year.

ii) To pass Annual budget.

iii) To approve the Balance Sheet.

iv) To issue instructions to the office bearers and the Governing body, for the proper administration of the institutions run by the society.

(b) The General body shall elect President, Two Vice-Presidents, Secretary, Treasurer as office bearers, once in every 5 (Five) Years at a special meeting held in the month of June.

(c) The Committee shall have power to frame or amend or repeal or cancel laws from time to time not inconsistent with the provisions of the Memorandum at a Special meeting convened for the purpose by 2/3 of the members present.

(d) The General body shall have power to either accept or reject any donation without assigning any reason and none can question or find fault with the General Body.

9. The General body shall have all powers as necessary or incidental for carrying out the objects of the society.

10. The General body shall have power to acquire property for the benefit of the society or any of the institutions run by it.

11. The General body shall have power to write off any arrears or to authorise the president and Secretary to deal with or Compromise the litigation.

12. The General body shall have power to appoint auditors.

13. The President and Treasurer shall Jointly operate on Banks.

14. Any member of the Committee shall have the right to send proposals in writing to the Secretary for inclusion in the Agenda of the meeting of the General body.

15. Meeting of the General body:-

a) Ordinary meeting of the General body:-

The ordinary meeting shall be convened with 7 clear days notice by the Secretary. The meeting convened under Act 8(a) is called the ordinary meeting.

b) Special Meeting:-

The Special meeting shall be convened with 15 clear days notice by the Secretary for purpose of election of the office bearers and the Governing body.

c) Emergency Meeting:-

The President or Secretary shall convene any emergency meeting in their own initiative to transact any matters of urgent importance with 3 clear days notice.

d) Requisition meeting:-

Any Twenty five members or $\frac{1}{10}$ of the members of the General body which ever is less stating the purpose of the meeting shall demand in writing the convening of an ordinary meeting of the Society with one month's notice. If within one month after the receipt of such requisition, the Secretary shall convene the meeting asked for, the members themselves shall convene the meeting and the resolutions adopted at such a meeting shall be valid and binding on the Society.

e) Notice shall mean and imply notice delivered in person or by post under certificate of posting.

16. All matters shall be decided by a vote of majority of members present at the meeting of the General body.

17. The President shall have a casting vote in case of a tie.

18. QUORUM:

a. The quorum for any meeting of the General body shall be 10% of the members on the rolls.

b. If there is no quorum in any meeting within 30 minutes from the time notified for the meeting, the meeting shall be adjourned to a convenient date with the same Agenda. For the adjourned meeting no quorum is necessary.

19. a. All documents such as sale deeds of any kind shall be executed in the name of the society represented by the President and Secretary of the society.

b. The President and the Secretary of the Society shall jointly execute sale deeds or any deed regarding the acquisition, disposition etc., of Properties. They shall jointly exchange or sell any property of the society, for the benefit of the society.

20. Governing body:-

There shall be a governing body to look after the day-to-day management of the College.

21. a. The Governing body shall consist of President, Two Vice-Presidents, Secretary, Treasurer and Six members.
(Two members shall be elected by professors from among themselves, Three members shall be elected by patrons from among themselves, one member shall be elected by life members among themselves)

b. The Principal of the College shall be the ex-Officio member.

c. There shall be one representative of the Teaching staff.

d. There shall be one representative of the Government of Andhra Pradesh.

N.B:-To elect the members to the Governing body from the different categories of the General body it is necessary that a member shall be duly proposed and seconded by another member of the same category.

e. The correspondents shall be elected by the members of the Governing body from among its members.

- f. The President, Two Vice-Presidents, Secretary, Treasurer of the General Body shall be the President, Two Vice-Presidents, Secretary and Treasurer of the Governing body.

22. Functions of the Governing Body:-

1. The Governing body shall exercise General control over the policies of the institution, establish and maintain sound traditions and attain its educational aim.
2. All monies of the Society shall be kept in Scheduled Bank or Banks approved by the Society.
3. The Governing body shall have power to lease out the Properties of the Society.
4. The Governing body shall have power to obtain properties or buildings or lands on lease for the benefit of the Institutions of the Society.
5. The Governing body shall have power delegate any or all of its powers to the President and Secretary.
6. The Governing body shall have power to appoint any person or a committee to inspect the staff Registers, accounts and other documents of the institution.
7. The Governing body shall receive reports of the Principal and correspondent of the College every year and review the same.
8. The Governing body shall maintain, construct, alter any structure building and provide amenities to the staff and the students.
9. The Governing body shall have powers to appoint, promote, demote any of the staff and it shall be made at a special meeting.
10. The Governing body shall have power to determine the conditions of appointments or service of its staff.
11. The Governing body shall submit the Annual Budget for approval by the General body.
12. The Governing body shall make arrangements for annual audit of accounts of the College Committee by the auditors appointed by the General body.
13. The Governing body shall place the Audit report of the previous year and the budget estimates for the next year before the Annual General body meeting of the committee;
14. The Governing body shall make rules and regulations for the internal administration of the institution run by the society from time to time.
15. The Governing body shall be the custodian of all the properties of the College.
16. The Governing body shall be convened at least thrice in the year.
17. All matters shall be decided by a vote of majority of members present at the meeting of the Governing body.

18. The President shall have a casting vote in case of a tie.
19. A member of the Governing body shall have right to send proposals in writing to the Secretary for inclusion in the Agenda.
23. Meeting of the Governing body:-
 - a. Ordinary meeting:- A week days clear notice shall be given for convening an ordinary meeting.
 - b. Special meeting:- 10 days clear notice shall be given for convening a special meeting of the Governing body.
 - c. Emergency meeting:- One day clear notice shall be given for convening an emergency meeting.
 - d. Requisition meeting:-
Five members or $\frac{1}{2}$ of the members of the Governing body which ever is less stating the purpose of the meeting shall demand in writing the convening of an ordinary meeting with one month notice. If within one month after the receipt of such requisition, the Secretary shall not convene the meeting asked for, the members themselves shall convene the meeting and the resolutions adopted at such a meeting shall be valid and binding on the society.
 - e. Notice shall mean an imply notice delivered in person or by post under Certificate of posting.
24. QUORUM:
 - a. The quorum for the meeting of the Governing body shall be five.
 - b. If there is no quorum in any meeting within 30 minutes from the time notified for the meeting, the meeting shall be adjourned to a convenient date with the same agenda. For the adjourned meeting no quorum is necessary.
25. The President:
 - a. The President shall preside over all the meetings of the General body and the Governing body.
 - b. The President and Treasurer shall have power jointly to incur an expenditure not provided for in the budget to an extent of Rs.1,000/- at a time and not exceeding Rs.15,000/- in a year and shall get such expenditure ratified at the next meeting of the society or Governing body to which it is related. If, on any special occasion, it is found necessary to incur an expenditure exceeding the specified amount of Rs.1,000/- at a time, the treasurer shall spend the necessary amount and shall obtain the ratification of the Governing body or General body to which it is related at its next meeting.
 - c. The President shall appoint the staff of the College if any vacancies arise in the middle of the year in consultation with the Principal and the Correspondent and shall get such appointment ratified at the next Governing body meeting.
 - d. The President shall have power to add items to the Agenda of the General body or the Governing body meetings whenever he feels necessary.
 - e. The President, when he is absent from head quarters for over a period of 15 days, shall delegate his powers to the Vice-President in writing.

- f. The President at the request of the Correspondent in writing, shall barrow monies from among the General body members or from out-siders to meet the salary demands of the staff or demands of the buildings and equipments etc., repayable with interest.
- g. The President shall be deemed to have vacate his office when at a special meeting of the General body constituted for the purpose, two thirds of the general body members express lack of confidence in him.
- h. No motion of no confidence can be moved within one year after the election of the President or until a lapse of one year after any such motion has been made and defeated. His successor shall hold office for the unexpired portion of his term.
- i. The President can fill up the Vacancies caused us any reason in the working committee by amongst the members which shall be ratified by the next general body meeting.

26. Vice-President:-

- a. In the absence of the President, the Vice-President shall preside over the meetings of the general body and Governing body.
- b. When the President delegates his powers to the Vice-President, he shall act as President.
- c. The Vice-Presidents is removal by a vote of no-confidence as in the case of the President.

27. Secretary:-

- a. The Secretary shall be in-charge of all the records of the society and maintain its accounts.
- b. The Secretary shall convene the meetings of the General body and the Governing body. He shall also convene a meeting when he receives a requisition either of the General body or of the Governing body.
- c. The Secretary shall be the Chief executive of the committee and shall carry out all the resolutions of the General body and Governing body and submit report from time to time.
- d. The Secretary shall place at the Annual meeting of the General body the budget, Assets and Liabilities statement prepared by the Treasurer.
- e. The Secretary shall prepare Agenda for the meeting of the General body and the Governing body in consultation with the President.
- f. All documents and title deeds of various properties of the society shall be in the hands of the Secretary. The Secretary is removable by a vote of non-confidence as in the case of the President.
- g. The Secretary has power to sue and being sued as in-charge of the society in any legal proceedings.

28. Correspondent:- There shall be a Correspondent to lookafter the day-to-day administration.

- a. The Correspondent shall be elected from among the members of the Governing body by the members of the Governing body.
- b. The correspondent shall call for and obtain from the principal all returns and information required from time to time by the Educational Department, Government of A.P. and the Governing body.

- * * * * *
- c. The Correspondent shall prepare and give the Governing body for its approval, a report at the end of every academic year regarding the work of the Colleges, together with a report from the Principal as to the adequacy of staff, strength of the institution and needs of the institution.
 - d. The Correspondent ~~as~~ shall have the power to award punishment such as suspension or with holding increment to any of the erring members of the staff.
 - e. An appeal against the punishment by the Correspondent shall lie to the Governing body within 15 days of the orders of the punishment.

29. Treasurer's duties:-

The Treasurer shall receive all money on behalf of the Society and make payments on behalf of the Society.

30. Dissolution:-

In the event of the dissolution of the society all the remaining funds and assets will be transferred to any other institution having similar objects and aims which has been recognised by the Income Tax Authorities as registered under section 12 A of the I.T Act and to whom the provisions of section 80 G(5) shall apply.

31. Funds:-

The funds shall be spent only for the attainment of the objects of the society and no portion thereof shall be paid or transferred directly or indirectly to any its members through any means.


